

ORDINANCE ____ -- _____

AN ORDINANCE OF THE CITY OF GALVESTON, TEXAS, IMPOSING MANDATORY RATIONING OF CRITICAL RESOURCES NECESSITATED BY REASON OF HURRICANE _____; PROVIDING FOR A PENALTY FOR VIOLATION; MAKING VARIOUS FINDINGS AND PROVISIONS RELATED TO THE SUBJECT AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Galveston Island was severely damaged by Hurricane _____ and critical resources are in short supply; and

WHEREAS, the scarcity or threat of scarcity of critical resources necessitates immediate protection against further unnecessary loss of resources;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GALVESTON, TEXAS:

SECTION 1. The findings and recitations set out in the preamble to this Ordinance are found to be true and correct and they are hereby adopted by the City Council and made a part hereof for all purposes.

SECTION 2. It shall be mandatory, absent proper authorization from the City of Galveston, for every person or entity, to conserve and ration all critical resources. Critical resources shall include but is not limited to the following: water, fuel of any kind, batteries, utilities, and food items.

SECTION 3. It shall be unlawful for any person or entity, without proper authorization, to fail to ration such critical resources as mandated by the City of Galveston.

SECTION 4. Any person or entity who shall violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined in a penal sum not to exceed \$1,000.00.

SECTION 5. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this Ordinance should be declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance.

SECTION 6. All Ordinances or parts thereof in conflict herewith are repealed to the extent of such conflict only.

SECTION 7. In accordance with the provisions of Sections 12 and 13 of Article II of the City Charter this Ordinance has been publicly available in the office of the City Secretary for not less than 72 hours prior to its adoption; that this Ordinance may be read and published by descriptive caption only.

SECTION 8. This Ordinance shall be and become effective from and after its adoption and publication in accordance with the provisions of the Charter of the City of Galveston.
