  - Texas Legislature





As deadly wildfires raged across Southern California in January, a Los Angeles city official lamented to the city council and others how they were forced to listen to hateful, vulgar language from some members of the public.

He thanked the audience for their patience in listening to one man's tirade in which he yelled "burn, Palisades, burn!" and used the N-word to describe council members.

It was far from an isolated incident.

A small group of people have repeatedly shown up to comment at the council meetings, spewing the N-word and C-word while ranting about everything from the city's homeless crisis to mask-wearing and the 2028 Olympics.

## Open Records Requests

### How one man's open records obsession sparked a fight over transparency and power in East Texas



Once a tool of journalists and concerned citizens to hold government accountable, open records requests have been increasingly used by political opponents and conspiracy theorists to slow down the pace of government.

Cassel, in an interview, denied Stua's frenetic open records requests were linked to the charges he has faced. And, she said, her office has followed the law in processing his requests.

Stua's case highlights the tension between the public's right to know and a government's ability to get work done. And it opens a window into small-town politics of Texas lore, where everyone knows everyone.

Once a tool used largely by journalists and concerned residents to hold government accountable, open records requests have increasingly become weaponized by political operatives and conspiracy theorists. Stua was an early adopter of the tactic.
